**MEETING MINUTES**

**Tuesday, March 21, 2017 – 6:30 p.m.**

Chairperson Lizz Kohazi called the meeting to order at 6:30pm and welcomed everyone. Debbie Johnson led the faith sharing.

**Review and Approval of the February Meeting Minutes**

Upon completing the faith sharing, Ms. Kohazi asked if everyone had reviewed the February 21, 2017 Meeting Minutes. With no changes, the minutes were accepted as presented.

**NEW BUSINESS**

**March 10<sup>th</sup> PPC Lenten Soup Supper and Stations Review**

Father Albert stated that the Soup Supper and Stations went very well. He was pleased with the participation and the flow of the stations.

**Holy Week Update**

Ms. Johnson reviewed the Holy Thursday foot washing. She suggested that instead of the chairs on the altar that those having their feet washed should sit in the first pew and process in at the beginning of mass with the servers, Deacon Bruce and Father Albert. Father Albert agreed to try this idea out for this year.

**Nomination Process Review**

Council members reviewed the PPC nomination process. It was discussed that Ms. Johnson and Ms. Troxtell give a testimony about their service on the Parish Pastoral Council as this is their final year. It was noted that this could motivate others to serve.

**Custodial Issues**

Ms. Kohazi led a discussion on several custodial issues including:

- Father Albert suggested that some parishioners who are interested in some deep cleaning of our parish hall could be asked to help out when available.
- Ms. Parobek asked about installing a railing on the side of the church where Ms. Brown, the cantor, stands. Discussion ensued but no action was taken on this issue.
- Council members discussed the flooring in the church hall, which is in bad shape and that it should be stripped and waxed or replaced sometime in the very near future.

### **Stewardship Campaign Summary**

Mr. Jerrome gave a brief update on the Stewardship Campaign. Mr. Jerrome shared a spreadsheet of the results of the campaign, including the current ministries that parishioners are involved in and those that are interested in certain ministries.
